

From the Family and friends of Marwa El-Sherbiny to the whole world:

Alexandria, 2 - 7 – 2009, in the afternoon, we knew about the murderer of our beloved daughter in the Court of Dresden by a German extremist.

We first thought that this accident is an individual incident done by the killer, but when we checked with our Embassy in Berlin we were shocked that no one informed them about the accident.

Many of the happenings in this case confused us:

- How could this happen inside a court in the Europe's heart in the twenty-first century
- How an experienced federal police officer fire the victim who was bleeding and stabbed
- How did nobody think of saving the child who was covered by his mother's blood.....!!!!

However, since we are educated Egyptian Muslims, it is our duty to await the verdict; we know that in Europe there is a fair law, so we filed three applications to the General prosecutor in Dresden against:

- Killer
- Court representative
- Police Officer

After a period of time we were informed by the German lawyers that only one case is transferred to the court to be held on 26 -10 - 2009 as for the rest of the files, they are still pending for reasons we do not know so far.

We went to Germany crossing hundreds of miles seeking our right wishing a fair verdict to be declared by the German judiciary.

We have been in Dresden court for two whole weeks, attending all conventions and hearing all witnesses then came the judgment day on the 11 -11 - 2009

We want everyone to know that we are not against the German judiciary and we have no problem with any German citizen, but at the same time we have big problem with anyone who tries to diminish Marwa's right.

We still wonder about the following:

1 - How would the police- in a German state in the 21th century, on 1 -7 - 2009 when they found a whole family perished: a mother killed with 19 stabs and a father between life and death with 16 stab and gunshot wound and a child covered with the blood of his mother screaming- do not act but leaving the mother in the morgue and the father in the intensive care and the child with a substitute family and that to be all. They went all at home on that day sleeping without notifying anyone about the accident not even on the next day and chose to remain silent.

We learned about it by accident although Marwa and Elwy entered the court and were identified by the chief judge from their passports and mentioned the work place of the spouse No one was informed not the work place, not the family nor the embassy.

2- How would an explicit threatening letter sent to the Court by the murderer on the 28th of October 2008 nine months before the accident not to be taken seriously by the judge.

An explicit threat to Marwa and insulting to Islam, Muslims and God was in the hands of the prosecutor, the judge of first session, and the judge of appeal and no one of them thought about protecting the victim, or notifying or even warning her, which in turn led to this tragedy. That reflects the lack of respect for Islam, Muslims and God from whoever read this letter.

3 - How to allow anyone to carry weapons or knives inside the only place that people refuge seeking their rights and not losing their lives, the place that end disputes between parties.

People enter the court and are already at clashing with each other so what would it be in the presence of a threatening letter.

4 - How didn't the Judge press the alarm button from the first time he saw that Marwa was hit by the murderer, even that "according to his testimony" he saw her hit by hand not by knife? And if he did press the alarm why nobody showed up? We also noticed that the guards Court are not armed.

5 - How would a tall & strong federal police officer "Mr. Raul" by the first time he heard the screaming and went to see what is going on in the Hall incident, next door to the room he was at; did not think for a moment to save the child or to call for an ambulance, and did not interfere but preferred to go out calling his colleagues as if the killer will wait.

6 - How would the federal officer choose to fire on Elwy instead of the killer to be his first action instead of first warning them that the police is surrounding the killer or firing a bullet in the air to scare them or interfering by hands as for the public information, Mr. Grim and his three colleagues were very close to both (~1.5 meter away).

During the trial, when the family's lawyer was questioning the witnesses about the officer who fired Elwy or about the judge or the Court's responsibility, they were strongly met with aggression stating that these issues are not the subject for discussion now, but those files are currently being considered and when they will be transferred to the Court, then the details will be discussed and the current topic now is the killer only and we respected that. But when the verdict was stated, we found the following:

After the judgment was declared, the judge read the verdict details and we were shocked that she spoke about the police officer that he is not guilty, he got confused because the killer looks like the victim as they have the same skin and hair color, although the killer is white and has brown hair whereas the victim's hair is dark and his skin is light brown, the killer does not wear eyeglasses but the victim does, the murderer was holding the handle of the knife whereas the victim was holding the blade, the victim was bleeding everywhere from his body including the neck and face but the killer was not.

- As regarding the court's responsibility, the judge reported that the court is not supposed to provide protection in civil cases and also to protect everyone who enters it, although this is not the situation the divine self the divine self the divine self the divine self the divine self the divine self in the other German states.

- She also criticized what was written by Muslims and Arabs on the internet against the officer and the responsibility of the court and said the German officer did not shoot the victim because of his darker skin, although that was not the subject then.

- She reported that if she was in the court of first and second degree instead she also would not realized the seriousness of the case, despite the presence of the threatening letter in the case file, which includes an explicit threat to Marwa and insulting to Islam, Muslims and God, there is something unusual is happening in each German issues.

How then when we tried to talk about these issues we are met with a complete rejection and the judge's sentencing-denying the police officer and the court responsibility- is heard and written and recorded by the world and we have no right to comment.

We therefore ask the German judiciary to submit the files in the Prosecution to the court for execution We respected the declared judgment against the killer, but we oppose who are trying to promote that it is the maximum penalty of German law because the maximum sentence in German law is a life prison with tight security.

Finally, as the accident was unique during which the killer has taken the whole court lightly and made two crimes, the verdict must match the incident to punish anyone who participated in or failed to perform his job as a restraint and a lesson for all.
