Letter of objection

To the Court of Dresden from Alex Wiens, on 28/10/2008

According to my knowledge no one so far has canceled the rights of citizenship, and so I ask for a lawyer to defend me, and the State to bear the fees, I also demand that this dispute is to be executed by the Court.

And I knew from the Court's call to me is that I am supposed to bear the expenses of litigation, "Is this the new source you found to get the money?? There is nothing wrong! But you can forget this immediately as I reject this principle.

I would rather die than have to pay myself to punish me, what spirit of deviant thought of something like this?

And I do not understand since when it is forbidden in this country that is "state of law" to tell the truth,

I was charged because I said to a Muslim "Islamist" this nonsense is not acceptable! Every person belongs to the Christian religion is a Christian, and everyone who belongs to the Islamic religion is Islamic,

And everyone knows that Islam is a dangerous and crazy religion, and his followers believe that the "non islamists" are not real human beings and that they must be evacuated or persuade them to religion, and I do not recall here that the Islamists living in Germany do not want to accept the country and its culture as it is, but also want to do all effort to change it according to their taste and fantasy crazy religious rather than adapting to the country. Due to all that, I certainly see Muslims as the enemy and I try as much as possible not be in contact with any of them, and if they have to get near me - despite my warning to them - I become nervous and no one - in the world - can tell me that I have to stand the enemy beside me.

And at first I did not want any confrontation with this Islamic, she was determined, and this proves once again that she is - like other Islamists - entirely stupid, and to say the truth I should say

"The insanity of Islamists stems not only from religion, but it is primarily the result of the same race if not the culture would have developed in a different way. "

You also charged me that I said that "Germany does not need to Islamists," Isn't this the truth? Whoever says that Germany will fall without the Islamists, he is certainly either a traitor or Muslim. This "lady" - which you accused me of insulting her - was wearing a veil, one of the manifestations of a total submission to the religion, to the culture, to men and to God (he described god by a word we can't write)therefore insulting the history and the culture of Germany thus myself.

Isn't it crazy not to allow women to show their hair to the public? This happens also without their consent. This is the slow daily destruction to the culture of this country and not always

visible. This is what our children see in the children's playground, but this is not the worst thing, the worse thing is that children get to be normal after that.

I feel that the German justice act arbitrarily to me, and what i understood from the court through a letter that I am threatened by a month of prison, and why? Because of a few words and even is the truth? I am sure I am the victim of this sense of guilt in front of the German history and the victim of the political non-understandable policies to satisfy foreigners at the expense of the Germans.
